Candidates will have to produce testimonials in original, in the event of being selected for interview failing which his/her candidature will be rejected and the next eligible candidate from the merit list will be considered.

7. The intending candidates shall submit their applications through proper channel including experience certificate issued by the respective District and Sessions Judge or equivalent courts along with copies of **service-book, five years ACRs** with proof of requisite educational qualifications.
8. Candidates must be an Indian Citizen as defined in Article 5 to 8 of the Constitution of India.
