RE-ADVERTISEMENT

Pursuant to the **Notification No.1, Dtd. 04.01.2021** and **Notification No.2, Dtd. 26.04.2021**, issued by the Hon'ble Gauhati High Court, the earlier **Advertisement dated 13.10.2020** in respect of the office of the Special Judge, CBI, Assam, Additional Court No.1 and **Advertisement dated 15.05.2018** in respect of the office of the Special Judge, CBI, Assam, Additional Court No.2 published for recruitment of **Night Chowkidar** in both the Courts, has been **cancelled**.

ELIGIBILITY

- **Qualification** : **Minimum Class-VIII standard and those who have passed HSSLC or above shall be ineligible to apply.**
- **Age limit** : **Minimum 18 years and maximum 40 years as on 01.12.2021.**

GENERAL CONDITIONS

- The application shall have to be submitted in Standard Form along with self-attested copies of relevant Academic Testimonials including birth certificate in support of age etc.
- **3 (three) copies of recent passport size colour photographs** should be enclosed with the application.
- Last date of receipt of application: **on or before 5:00 PM of 18.12.2021.**

- No application will be entertained after scheduled date for receiving the application. The authority shall not be responsible for any postal delay.
- Valid Employment Exchange Registration Number/ Certificate is mandatory for applying for the posts.
- Candidates willing to apply for both the posts have to file **separate applications**.
- Applicants shall have to mention his/her valid mobile number in the application, if any.
- **The selection process will comprise of Interview/Viva-voce.**
- **Applicants are advised to visit the official website of Kamrup (Metro) District Judiciary at www.kamrupjudiciary.gov.in and the office Notice Board for the list of eligible candidates for Interview/viva-voce test and for the rejected list of candidates.**
- Place and date of the interview will be notified in due course through the District Judiciary website at www.kamrupjudiciary.gov.in and in the office Notice Board. **No separate Call Letters for Interview/Viva-Voce shall be issued.** No TA/DA will be paid for the same.
- Canvassing directly or indirectly will disqualify the candidature.
- **Incomplete/defective** applications will be rejected without any intimation.
- Concealing/Suppression of educational qualification, age, date of birth etc. will lead to automatic disqualification of the candidature, even if provisionally selected, without intimation.
- In view of FR 11, the appointing authority reserves the right to utilize the service of the employees for any other purpose other than to which he is appointed, including utilization of his service on holidays, if the situation so demand in the public interest.
- Applicant selected shall be governed by new set of pension rules which have been formulated by the Government.
