## Advertisement for the Post of Principal

In continuation of our earlier advertisement No. CD/SV/RL000474/1 published in the Assam Tribune dtd. 3<sup>rd</sup> November, 2021, it is hereby notified that in pursuant to the permission for advertisement for filling up the vacant post of Principal accorded by Hon'ble DHE, Assam vide order No. DHE/CE/Misc/149/2017/87 dated Kahilipara the 8<sup>th</sup> Oct. 2021, applications with complete bio-data and other supporting testimonials from HSLC onwards are invited from eligible candidates for the vacant post of regular Principal of Nalbari Commerce College, Nalbari so as to reach the college office on or before 20<sup>th</sup> December, 2021 up to 4 p.m.

### Qualifications:

- 1) A Master Degree with at least 55% of marks or equivalent grade in point scale wherever grading system is followed.
- 2) A Ph.D. Degree in concerned/allied/relevant discipline(s) in the institutions concerned with evidence of published work.
- 3) Professor/Associate Professor with a total experience of 15 (fifteen) years of Teaching/Research/Administration in universities/colleges and other institutions of higher education.
- 4) A minimum score as stipulated in the Academic Performance Indicator (API) based on PBA in Appendix-III for direct recruitment of Professor in colleges.
- 5) A relaxation of 5% marks may be provided at the Graduate and Master Degree Level for SC/ST/Differently Abled (Physically and Visually) categories for the purpose of eligibility and for assessing good academic record.
- 6) A relaxation of 5% marks may be provided from 55% to 50% of the marks to the Ph.D. Degree holders who have obtained Master Degree prior to 19<sup>th</sup> September, 1991.
- 7) Upper age limit of 55 years as per prescribed rules.
- 8) A minimum of 10 research publications in peer reviewed or UGC listed journals.
- 9) A minimum of 110 research score as per Appendix-II at Table-2.
- 10) Employees of Govt./Provincialized colleges shall have to apply through proper channel.
- 11) The term of Principal will be of 5 years.

Application should be filled in the prescribed proforma issued by the Director of Higher Education, Assam and sent/submitted through Registered Post to the President, Governing Body, Nalbari Commerce College, PO: Chowkbazar, Dist.: Nalbari, State: Assam, PIN: 781334 with a Bank Demand Draft of Rs. 5000/- (Rupees Five Thousand) only (Non-refundable) in favour of the Principal i/c cum Secretary, Nalbari Commerce College, Nalbari payable at Nalbari.
