Terms and Reference for advertisement for temporal/contractual post in the Office of the Commissioner, Panchayat & Rural Development, Assam

Commissioner, Panchayat & Rural Development, Assam, invites online applications from eligible candidates who are citizen of India as defined under Article 5 to 9 of the Constitution of India.

Background:

The Panchayat & Rural Development Department largely works to enhance livelihood opportunities, address chronic poverty, provides social security and works for economic inclusion of rural poor families. The Shyama Prasad Mukherji Rurban Mission (SPMRM) follows the vision of "Development of a cluster of villages that preserve and nurture the essence of rural community life with focus on equity and inclusiveness without compromising with the facilities perceived to be essentially urban in nature, thus creating a cluster of "Rurban Villages".

The 6 (six) positions advertised here are of Rural Development Management Professional (RDMP), for Shyama Prasad Mukherji Rurban Mission (SPMRM).


1. The eligibility norms of educational qualification, age, work experience etc. as mentioned below for the six purely contractual post:

2. The posting of all the six post will be in the (4 Districts/6 Clusters) namely Phuloni, Bokajan, Diphu (Karbi Anglong District), Tamulpur (Baksa District), Kalain (Cachar District) and Chandrapur (Kamrup Metro District) respectively.
3. The opening of positions published is as per program requirements. Number of positions may be increased or decreased as per programme requirement and approval.
4. The department reserves the right to cancel any or all position at any stage of the recruitment process.
5. At any stage of recruitment, if it is found that the candidate does not fulfil the eligibility criteria and /or that he / she has furnished incorrect/false information / certificates / documents or has suppressed any material fact (s), his / her candidature/appointment will stand cancelled and necessary legal action will be initiated.
6. The decision of the Selection Committee in any matter related to the recruitment at any stage of the recruitment process will be final and binding upon the candidates.
