Eligibility Criteria:-

1. He/ She must be a citizen of India and a local resident of Barpeta District.
2. He/ She should have the requisite mind-set to assist the needy in society, and have the compassion, empathy and concern for the upliftment of marginalized and weaker sections of the society.
3. The application should be addressed to the “District & Sessions Judge cum Chairman, District Legal Services Authority, Barpeta” and submitted in the office of District Legal Services Authority, Barpeta.
4. Filled up application with bio-data and photographs should reach the office address of District Legal Services Authority, Barpeta, on or before 31-03-2022, during working hours. Applicants should submit their mobile / contact number; email id for further communication. Applicants having practical experience in the field of Social work will be given preference.
5. No applications will be entertained after the last date of submission, i.e., 31-03-2022.
6. Applicants should mention their respective Gaon Panchayat to which they belong, along with their complete address in the bio data.
7. The work of PLVs doesn't carry any salary, remuneration or wage except honorarium fixed by the District Legal Services Authority, Barpeta from time to time, as per rules.
8. The decisions of the Selection Committee in short listing the number of candidate for interview and selection of PLV shall be final. The eligible candidates shall have to appear for Interview before the Selection committee, the date of which will be notified in the official website.
9. Selected PLV shall be required to undergo training programme as per decision of the District Legal Services Authority, Barpeta.

10. In case of any objection regarding selection of PLVs, the decision of the Chairman , District Legal Services Authority , Barpeta shall be final and binding on all concerned.
