

ELIGIBILITY FOR APPLICANTS

Applicants must fulfil the educational qualification, experience and age limit and other criteria for the post applied for, as on the last date of receipt of the applications, failing which the application shall be summarily rejected and no correspondence will be entertained in this regard. *AGE RELAXATION FOR GOVERNMENT SERVANTS/SC/ST/OBC's/Others

The upper age limit is relaxable for Government servants' upto 10 years.
