ELIGIBILITY:-

- 1) The candidate must be an Indian Citizen.
- 2) The candidate must possess the minimum educational qualification of HSLC passed and the candidates must have knowledge in official language of Assam.
- 3) The candidate must not be less than 18 years and more than 40 years of age as on the date of application. The upper age limit will be relaxed by-
 - (i) By 5 years for ST and SC candidates i.e. up to 45 years as per Govt. Notification No.ABP.6/2016/51, dated 02-09-2020 issued by Department of Personnel, Government of Assam,
 - (ii) By 3 years for OBC / MOBC candidates i.e. up to 43 years as per Govt. Notification No.ABP.6/2016/51, dated 02-09-2020 issued by Department of Personnel, Government of Assam,

HOW TO APPLY:-

Eligible candidates will have to apply in Standard Form of Application (published in the Gazette Part IX of Govt. of Assam) and must submit to "The District & Sessions Judge, Bajali, Pathsala, District Judicial Court Complex, Madan Rauta Nagar, Pathsala - 781 325". The Last date of receipt of application is 21-01-2023 till 4.00 PM.

- 2) The application must be accompanied with the following :-
 - (a) Three recent coloured-passport size photograph with signature on the reverse side,
 - (b) Self-attested copies of testimonials in support of his/her AGE, CASTE, EDUCATIONAL QUALIFICATION etc.
 - (c) Mobile Nos. must be written on the top of the Standard Form.
- 3) Candidates already in govt. service must apply through proper channel.
- 4) Incomplete or late received applications will summarily be rejected.
- 5) If any candidate found canvassing directly/indirectly his/her candidature will be rejected.
