No.' and the 'Post Applied For' should be mentioned on the envelope so as to reach on or before the closing date i.e.29.01.2023.** Applications not in prescribed format or without supporting documents for Age, Qualification and Experience etc or sent through any other modes viz email, fax and by hand etc. shall be summarily rejected/not acceptable.

3. During the validity of the Contract of engagement, while on duty, engaged person shall (i) observe the punctuality & discipline (ii) attend Office on all working days and if necessary on holidays. If required, he/she will have to work even beyond normal office hours.

4. 8. The engaged person will have no right to claim any additional benefit/ compensation/absorption/ regularization of services in the Corporation during or after the period of engagement under any provision.

9. The engagement will be for a period of one year. However, depending on the requirement of the Corporation and the performance of the person engaged, the period of engagement can be extended. The services of the contract employee will be terminated at any time even before the completion of the said period of one year.
