The upper age limit is relaxable by 03 years in case of candidates of OBC/MOBC, 05 years in case of candidates of SC & ST and 10 years for PWD candidates as per Govt. Office Memorandum No. ABP.6/2016/51, dtd.02/09/2020. Due weight age, preference and relaxation/condonation of over-age, if necessary shall be given by Selection Committee to the Addl. Mandal depending upon the length of service rendered by him/her as per Govt. OM No. RLR.92/95/Pt-1/104 dtd.23/09/2013. (2)Educational Qualification:-

- (a) The candidate must have passed HSLC examination or equivalent examination from any Central or State recognized
- (b) The candidate must possess a valid 06(Six) months RCCC training passed Certificate from Assam Survey & Settlement
- (c) The candidate must possess a minimum 06(Six) months diploma/ certificate in computer proficiency from a Govt.
- (d) The candidate must have the knowledge of English and Assamese typing.

6. Procedure of Selection: The Candidates whose applications are accepted as per eligibility criteria shall have to appear in a Written Test. The syllabus of the written test will be as follows:-

- Against each vacancy, 04(four) Nos. of candidates will be shortlisted on the basis of marks obtained in the written test.
- Preference will be given for absorption of Addl. Mandal as required under the O.M. No. RLR.92/95Pt-I/104 dtd.23/09/2023.
- The candidates shortlisted based on written test will have to appear in the computer Proficiency Test (Practical) of 25(Twenty Five) marks(both English & Assamese).
- 10.The candidates who qualify the written test must produce all original testimonials for verification at the time of computer proficiency test.
