Note 4:- For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 1st January 2006 or the date from which the revised pay structure based on the 6th Central Pay Commission recommendation has been extended shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale, and where this benefit will extend only for the post for which that grade pay or pay scale is the normal replacement grade without any upgradation.

8 Nature of duties

- S/he shall ensure collection of IRs of terrorists involved in various incidents in his jurisdiction and also interview the terrorists lodged in various jails to elicit further information.

		S/he shall raise sources and develop well placed contacts in his jurisdiction for collecting intelligence as per the task assigned by the organization.


