The applications should be submitted either by hand in the drop box kept in the office of the undersigned for the purpose or by post on or before 27.09.2023 upto 4 pm, with all testimonials supporting educational qualifications, age, caste and experience etc. Incomplete applications and applications received after 4 pm of 27.09.2023 will be summarily rejected.

Terms and Conditions:

1. Candidate must be Indian citizen as defined in the article 5 to 8 of the Constitution of India.
2. Candidates must not be less than 18 years and more than 40 years of Age as on 27.09.2023. The upper age limit will be relaxed by:
(i). By 5 years for ST and SC candidates i.e. up to 45 years as per Govt. Notification No. ABP.6/2016/51, dated 02-09-2020 issued by the Department of Personnel, Government of Assam.
(ii). By 3 years for OBC/MOBC candidates i.e. up to 43 years as per Govt. Notification No.ABP.6/2016/51, dated 02-09-2020 issued by the Department of Personnel, Government of Assam.
3. The candidates shall be required to appear in a Driving Skill Test followed by Personal Interview.
4. Date, venue, time of the Personal Interview/Driving Test, List of eligible candidates etc. will be published in the official website of Majuli District Judiciary.
5. No individual call letters will be sent to the eligible candidates. However, list of eligible candidates to be called for Driving Skill Test followed by Personal Interview will be uploaded in the official website of the District Judiciary, Majuli.

6. The candidates are required to download the admit card from the official website as per information given in the website in due course of time.
7. Candidates must have to enclose the following self attested copies of testimonials along with their applications:
 - a. Driving Licence.
 - b. Latest Employment Exchange Card.
 - c. Certificates, mark sheets in support of their educational qualification, age, caste, experience etc.
 - d. 3 (three) copies of recent Passport Size Photographs.
 - e. Candidates have to mention their Contact number at the bottom of the Application Form.
7. Candidates serving in Govt. departments should submit their application through proper channel.
